

No increases are anticipated, code updates are targeted to reduce flooding risk and increase environmental protection.

The proposal is likely to increase environmental quality, including plants, animals, fish, and marine life. The proposal includes updated FIRMs, which are based upon reliable scientific data. By adhering to the NFIP the County is eligible for the lowest cost federal flood insurance, as the County actively takes steps in the planning, permitting, and building codes to reduce and mitigate flood risk.

Adoption of the updates to the Jefferson County Code Chapter 15.15 (Flood Damage Prevention). The updates increase environmental and flood protection, which in turn have positive impacts on protecting and conserving plants, animals, and marine life.

The proposal is not likely to deplete energy or natural resources. The proposal will increase flood damage prevention and mitigation measures in building codes and project planning; thereby reducing risks of flood damage to natural resources.

The proposal will likely have a positive impact on the land and shoreline, including their uses as the flood zones are updated based upon reliable scientific data. Flood zones adjacent to shoreline jurisdiction is usually included as shorelands under the Washington State Shoreline Management Act and therefore, increases the jurisdiction of the SMA protected areas. These updates include new FIRMs for shoreline properties, based upon reliable scientific data.

This update brings the Jefferson County Flood Damage Prevention Ordinance into conformance with state and federal laws relating to flood protection. Jefferson County will delay the adoption of harmonizing ordinances for flood protection to the critical areas ordinance and shoreline master program until those programs are updated (expected to begin in 2019).
